

# Hole in One Insurance

## Proposal form



## Summary of cover

### Prize indemnity

Prize Indemnity provides cover for a competition in which the participants are offered the chance to win a prize by hitting a hole in one on a specific hole during a golf tournament. Hole in One insurance, often purchased by a golf tournament host or sponsor, reimburses tournament organisers for the cost of awarding a hole in one prize if a tournament participant successfully hits a hole in one during the golf tournament. We also offer 3 individual prizes on 3 additional holes, one prize per hole (values of £250, £100 and £50 respectively) within the policy for free.

### Re-instatement

Re-instatement provides cover for the prize to be re-instated should a hole in one occur, for only a small additional premium. Whilst the re-instated prize can only be won once, it does allow every participant a shot at the prize.

### Security

The policy will meet a claim if the hole in one is witnessed by a pre-disclosed and acceptable adjudicator and video-taped as proof on prize values of £25,000 and above. For prize values under £25,000 we will accept a pre-disclosed and acceptable adjudicator. The competitor must be a registered participant in the competition in order to qualify for the prize, and the participants original scorecard and original tournament pairing sheet must be presented as verification. Professionals are excluded.

### Official Witness/Adjudicator

**Your official witness must be employed in one of the following professions:**

- Teacher
- Doctor
- Lawyer
- Bank Manager
- Police Officer
- Veterinarian
- Qualified Accountant
- Company Director
- Justice of the Peace
- Golf Pro

#### Main exclusions

For full terms and conditions a specimen policy wording is available online.

- Claims where a winner has not been listed as a participant in the competition
- Claims where the hole in one has not been correctly adjudicated
- Re-instatement of the prize where the additional premium has not been paid
- A hole in one on any uninsured hole
- The insured hole being less than 150 yards

## Conditions applicable to the claims process

As with the other conditions applicable to the policy, make sure you read and are happy with these because they form part of the contract of insurance along with the conditions in the previous chapter.

### In The Event of a Hole In One

The Insured must notify EIS of any claims no later than the first business day after the **Event**.

The Insured will be required to provide EIS with the following documentation as proof of a Hole in One claim.

- A. A signed statement from, the **Official Witness, the Participant** achieving a Hole in One and all playing partners.
- B. The original winning scorecard.
- C. The original **Tournament** pairing sheet.
- D. Unedited original video footage of the successful Hole in One where the Prize Value is £25,000 or above.
- E. The **Participant** must complete the entire round of golf and complete the scorecard.
- F. The **Official Witness** must authenticate the scorecard of the Participant who achieved the Hole in One and all members of the playing partner's must also confirm the Participant's successful Hole in One on the Insured hole by signing the original scorecard.

*The above conditions act like exclusions, in as much, as failing to adhere to them, would cause the policy to not respond. They are specific to our Prize Indemnity policies.*
