Summary of cover

Prize Indemnity

Re-instatement

Re-instatement provides cover for the prize to be re-instated should a successful throw occur, for only a small additional premium. Whilst the re-instated prize can only be won once, it does allow every participant a go at the prize.

Security

The seven die are of standard weight and size with a maximum of six sides, with only one side per die having a number 6 printed on it, and can only be supplied by Event Insurance Services Ltd (unless agreed by us).
